## TOURISM AND BUSINESS VISA REQUIREMENTS

OFFICE HOURS: 10AM TO 12PM, MONDAY THROUGH FRIDAY

**NO VISA WILL BE PROCESSED BY MAIL OR COURIER SERVICE.**

Passport or USA "Permit to Reenter" valid for a minimum of six (6) months, from date of intended arrival in Brazil;

~~Alien USA Registration Card (Green or Pink Card) for permanent resident or, if you are planning to return to the USA and you are not a permanent resident, your USA visa must be valid for reentry to the USA, for a minimum of six (6) months (multiple entries) when you apply for a Brazilian Visa;~~

One (1) visa application form, for each applicant, provided by this Consulate, duly filled out and signed by the person in whose name the passport was issued (bearer);

One (1) passport-type photograph (2x2 inches), recently taken, in color or black and white. **Vending machine prints and tinted photographs are not accepted;**

~~Round trip ticket to Brazil or ticket in transit, with flight numbers, dates, or itinerary, must be presented. In lieu of the ticket the Consulate will also accept a signed letter from the carrier or travel agent, on company letterhead, with the name of the passenger, flight numbers, or name of vessel, itinerary, dates of arrival and departure, in and from Brazil;~~

~~Airline employees or standbys with open tickets must present ticket with itinerary and an airline ID card, or a signed letter from the airline, on company letterhead, with the name of the employee and his/her itinerary;~~

~~**FOR BUSINESS VISA ONLY:** A letter on company letterhead addressed to the Consulate, signed by an authorized representative (other than the candidate for the visa), stating the specific nature of business in Brazil, itinerary, business contacts, dates of arrival and departure in and from Brazil. The same letter should also state that the company assumes all financial and moral responsibility while the applicant is in Brazil~~

### ALL APPLICANTS UNDER 18 YEARS OF AGE MUST PRESENT:

- a. A Birth Certificate (original and photocopy), with names of both parents. This document must be in English or Portuguese. If in another language, an official translation in one of the above mentioned languages must also be presented.
- b. Proof of parents' country of birth and present nationality.
- c. If traveling alone, a letter, signed by both parents, **duly notarized**, giving permission for the minor to travel. It should also state the name and address of the person(s) responsible for the child while in Brazil.
- d. If traveling with only one parent, the same type of letter with the above ("c") information, signed by the other parent, **duly notarized**
- e. A certificate of vaccination against polio, stating kind and dosages of vaccine, is necessary for children between the ages of 3 months to 6 years old.

**JURISDICTION:** If you are a resident of the states of New York, New Jersey, Connecticut, Delaware, Pennsylvania, or Bermuda, you must obtain your visa at the **Consulate General of Brazil in New York.**

**TOURIST AND BUSINESS VISAS must be used within ninety (90) days from date of issuance. An extension for an additional period of three months may be requested from the Immigration Authorities in Brazil, prior to the expiration of the visa.**

**THE FOLLOWING SITUATIONS MUST BE CHECKED WITH THE BRAZILIAN CONSULATE BEFORE REQUESTING A VISA:**

- a) Children of Brazilian citizens born outside Brazil;
- b) Children born in Brazil to foreign parents; and
- c) Brazilian citizens who acquired another nationality by naturalization.

**\* FOR U.S. CITIZENS THERE IS A PROCESSING FEE OF US\$ 130.00 IN RECIPROCITY FOR IDENTICAL FEE PAID BY BRAZILIAN CITIZENS WHO APPLY FOR A VISA TO THE UNITED STATES OF AMERICA.**

**INCOMPLETE OR IMPROPERLY FILLED OUT APPLICATIONS** will cause delay and/or cancellation of the required visa.
